Employer mandate delayed for second year

The Obama administration on Monday announced it is delaying the employer mandate under ObamaCare until 2016 for some small businesses.

This delay in the mandate — the second so far — would only apply to businesses with between 50 and 99 employees, who would have until January 2016 to decide whether to offer insurance to their employees or pay a penalty. Businesses would also be barred from cutting their workers in order to fall under the threshold.

The employer mandate, a cornerstone of the healthcare law, was set to take effect in January, but the administration announced in July that companies would have until January of 2015 to comply.

Georgia sets record for imports/exports in 2013 for the 4th

year in a row. Governor Nathan Deal announced this week that Georgia imported \$37.5 billion in products last year while exporting goods valued at \$37.6 billion. In both cases, the volume of products moved increased about 3.6% from the 2012 numbers. "This is a clear indication that Georgia companies are aggressively pursuing international markets and that international companies are looking to Georgia for business", said Chris Carr, Commissioner of the Department of Economic Development.





The Senate Education & Youth Committee voted unanimously Thursday for legislation to force the state to retreat from the multi-state education standards called Common Core. Before the vote, the chairman of the House Education Committee announced his support for the measure and promised it would receive quick consideration there too. Conservatives across the state have complained that the standards permit federal intrusion and jeopardize the privacy of students. Chris Clark of the Georgia Chamber is publicly backing and asking everyone else to back the Common Core standards. Mr. Clark was quoted as

saying "It sends messages to companies all around the world that we're going backwards. We're not moving the ball forward; we're not having more rigorous standards. We want to lessen those standards and that doesn't give us a 21st century workforce." Ms. Carol Lane, Meriwether County School Superintendent is a strong supporter of the Common Core Standards and wants to remind everyone that curriculum remains flexible within schools, the standards simply establish common benchmarks for all children to achieve and allows them to be evaluated with other school children around the country.
